**INSPECTION:** All dogs will be inspected for soundness & measured prior to running each event. All bitches will be checked for being in-season prior to running each event.

## DOG ELIGIBLE TO ENTER

Open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not enter. A dog may enter only once per event. (An event is defined as an event number). Dogs requiring registry in Canine Partners must be spayed or neutered and are subject to a separate registration fee of \$19.00 for AKC.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

## TESTS, TITLES & TIMING

1. Fast CAT is a timed straight race of 100 yards.
2. Dogs run singularly.
3. The dog's time to complete the 100 yard dash is converted into mph.
4. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at the withers: a. 18" or greater = handicap is 1.0 b. 12" up to less than 18" = handicap is 1.5 c. Below 12" = handicap is 2.0
5. Points = MPH multiplied by the dog's handicap
6. FAST CAT suffix titles are earned at designated milestones:  
a. BCAT = 150 points b. DCAT = 500 points c. FCAT = 1,000 points d. FCAT# = each additional 500 points
7. Timing devices: The time to complete the 100 yard dash is recorded to the nearest 1/100<sup>th</sup> of a second (e.g. 9.11). The club may use break-the-beam equipment to obtain the time. If stopwatches are used, there shall be two timers positioned at the finish line. An individual at the start line shall signal with an arm drop the moment the nose of the dog crosses the start line. The timers shall stop their watches when the nose of the dog crosses the finish line. The times from the two stop watches shall be averaged to determine the recorded time.

### **Top 20 by Breed by Year**

## GENERAL RULES

### GENERAL RULES

1. All entries must be one year of age or older on the day of the test.
2. Each entry will be examined and may be measured with a wicket at inspection. Inspection shall take place prior to any form of wrapping being applied to the dog. In the opinion of the inspection committee, any entry found to be lame, unfit to compete, or a female in season, shall not be allowed to enter and entry fees shall be refunded. The decision of the field committee is final.
3. Dogs should be warmed up and cooled down before/after runs.
4. All AKC rules of sportsmanship and conduct shall apply
5. This is a rain or shine event. Bring whatever you need to keep you and your dog comfortable.
  
6. Muzzles are allowed. Dogs may wear any type of collar except no pinch collars, and no electronic training collars or devices are allowed. The club recommends using a plain collar and lead, and we discourage the use of flexi leads for safety reasons.
7. Electric continuous loop machines will be used. Lures consist of white plastic bags.
8. The field committee reserves the right to bar known aggressive dogs from the event site.
9. There will be a \$5 fine assessed for any loose dog not taking part in the course in progress (per AKC). The following actions may result in a fine and/or being excused from the event: exhibiting unsportsmanlike conduct, not picking up after one's dog, or littering in any area of the event.
10. NO ONE is allowed on the field without the express permission of the Field Chairman, except the appointed Field Committee.
11. There is NO SMOKING in the following areas: In and around the Paddock area, in and around the Secretary's table, and nowhere on the field itself. Please be respectful of others.
12. No entry fees shall be refunded in the event that the trials are cancelled due to acts of God, including but not limited to fires, war, riots.

## ADDITIONAL SITE INFORMATION

**Crating space** :There is a dirt parking lot. Bring your own shade and water.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

## RIBBONS, AWARDS, AND PRIZES

GLASWC will offer light blue flat ribbon for successful pass of test.

GLASWC will offer 1-4 place rosettes for

- Fastest under 12”
- Fastest 12” to 18”
- Fastest 18” or greater

GLASWC will offer a “New Title” rosette for any dog finishing a BCAT, DCAT or FCAT title.

## NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR and LIABILITY

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

**All dogs must be on leash** at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

### REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

**ELECTRONIC TIMERS WILL BE USED! The club will use break-the-beam equipment to obtain the time. AKC height cards will be accepted . Facility is not fully fenced. Track is fully fenced**
