Awards

Each dog passing Fast CAT will be offered a light blue qualifying ribbon. Dog must cross the start line and the finish line on its own. Dogs earning titles will be offered Rosettes.

Events offered and Other Important Information

NO BITCHES IN SEASON MAY RUN. ALL DOGS MUST RUN ON LIMITED SLIP OR FLAT COLLAR. NO CHOKE, PINCH COLLARS ALLOWED. TAGS SHOULD BE REMOVED OR TAPED FLAT TO COLLARS.

Fast CAT: Open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and spayed neutered dogs are eligible to participate. A dog may enter only once per event—defined by an event number.

The Event Committee reserves the right to bar known aggressive dogs. The Event Committee reserves the right to alter the track as required by weather and/or field conditions on the day of the event.

Two separate events are being offered each day and will run **concurrently**. You may use one entry form per dog to enter one or all events by circling the information on the entry form. Each event requires a \$25 entry fee for pre-entered dogs. Late entries and day of entries \$30. Conditional entries will not be accepted.

Entry forms may be completed online at www.socialscentwork.com (look under the Sprint Trials tab).

After completing the online entry, payment should be made through Zelle to daneenfox@aol.com. In the notes, please put your last name, the dog's call name, and the date of the event. Or, print the form and **mail it with a check made payable to: Daneen Fox, P.O. BOX 552, ACTON, CA 93510-0552.**

We are no longer using PayPal because of the extra fees. Please use Zelle, as indicated above, or send payment by check via mail.

You must provide two leashes for your dog; one to hold your dog and one to catch your dog. Please arrange for someone to either release or catch your dog, since you cannot be in two different places 100 yards apart. There will be dog holders/releasers, known as slippers at the staging area. Be sure your dog can be caught at the end of the course. Exhibitors should be familiar with all AKC Fast CAT rules prior to running. The Event Chairperson will have a complete copy of the rules available at the event site. Toys and treats may be in the catch area, out of sight, until the dog crosses the line.

REFUNDS

No refunds will be given for overpayment of \$6.00 or less.

No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbances, fire, act of God, public emergency, loss of site, extreme weather conditions, act of a public enemy, or any other cause beyond the control of the organizing committee.

No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

If an entry was made online, no refund of the service fee will be refunded for any reason.

Refunds for injured dogs or handlers: 50% refunds will be given for a dog or handler that has a note from their veterinarian or doctor saying they cannot participate in the show. The doctor's appointment must have been before the show.

Full Entry fees will be refunded if an entry is pulled before the closing date/ time. **However, online convenience fees will not be refunded for any reason.**

Bitches in season: AKC Section 3.2 Bitches in season, or bitches which come in season after the close of entries, shall be barred from participating in the event or trial and their entry fees refunded minus a \$5.00 processing fee. Notification to the Field Secretary of bitches in season must be made before or during inspection. Bitches known to be in season shall not be brought onto the trial grounds.

Trial Hours: 8:00am until 4:00pm. Actual start time will be determined at a later time.

Inspection and check-in will run at the beginning of each time slot. The two events will be run concurrently. The link to sign up for a time slot to run, for each day, will be sent via email to each competitor with the confirmation **after the entry is processed and payment is received.** Please arrive during your time that you signed up for. You will have plenty of time to run your dog(s) in that time frame. **All dogs will be inspected prior to their run as required by AKC.**

We are offering the flexibility for you to choose when to run your dog. Concurrent means you can run both runs in the morning, both in the afternoon. or one in the AM and one in the PM. We hope this reduces your stress level because we want you to have **FUN!!!!** Invite your friends!

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
